Loan Applications on prescribed Application Form ( available free of cost) are invited from the eligible persons belong to SC, ST & Safai Karamcharis categories, who are Permanent Residents of J&K State , living below double the poverty line i.e. having annual family income below Rs.98,000/-p.a. for Rural and Rs.1,20,000/- p.a. for Urban Areas in case of SC category and below Rs.81,000/-p.a. for Rural and Rs.1,04,000/- p.a. for Urban Areas in case of ST category ( in case of Safai Karamcharis / Scavengers and Handicapped categories there is no income criteria fixed by NSKFDC & NHFDC, however, preference shall be given to the persons living Below Double the Poverty Line) and who are not defaulters with any financial Institution, can apply for Loan Assistance, to establish the income generating units of the following types:-
